AWP 2014



Monitoring of national policies related to alcohol consumption and harm reduction (MOPAC)

MOPAC is a three-year project to support European Union (EU) and WHO collaboration in the monitoring and surveillance of EU and WHO European Region Member States' progress in reducing the harmful use of alcohol:

- Maintain and further develop the current system for monitoring trends in alcohol consumption, harm and policies by conducting 2 surveys.
- Further develop the functionalities of the EISAH and EUSAH online information systems.
- Publish 2 reports by using the collected data and by involving main actors in the field of alcohol policy.
- Enhance the capacity of Member States to contribute to and make use of alcohol information systems, and to implement key aspects of global-, regional- and EU-level strategies and action plans.

OECD Economics of Prevention

This Action aims at bridging an important gap in the information available to support key health policy decisions aimed at addressing the health and economic consequences of NCDs and the behaviours and risk factors associated with them. In particular, the Action will focus on obesity and harmful alcohol use and will assess their positive and negative economic impacts in terms of health care expenditures, other public and private expenditures, and broader economic costs.

- Review of existing models and conceptual frameworks
 - Empirical estimation of economic impacts
 - Assessment of impacts on human capital and educational outcomes
 - Assessment of the effects of public health policies
 - Production of country profiles

Raising awareness and action-research on Heavy Episodic Drinking among low income youth and young adults in Southern Europe (ALLCOOL)

Reduce alcohol-related harms among low-income youth and unemployed graduated young adults:

- Produce and **disseminate knowledge about HED** among low-income youth and unemployed graduated young adults in southern countries
- **Engage** and empower **local communities** to act on the HED phenomena
- **Educate low-income youth and unemployed graduated young adults** for alcohol-related harms of HED, harm reduction and safer drinking patterns
- **Build** best practice guidance and **capacity among Health/education/social workers** towards improving harm reduction responses on HED
- **Disseminate** the results and outcomes of the project at a regional , national and European levels

STAD in Europe (SIE)

Reducing binge drinking and its negative consequences, through restricting the availability of alcohol in different drinking environments (based on the STAD (Stockholm prevents alcohol and drug problems) approach).

1. **Development of 7 tailor-made interventions** (one in each participating country) to restrict the availability of alcohol;
2. **Implementation of the 7 interventions in the 7 pilot regions**
3. Conducting a **process and outcome evaluation** on both development and implementation of the 7 interventions
4. **Developing a digital manual** including the four intervention models and implementation strategies to restrict the availability of alcohol in nightlife settings
5. **Dissemination** of gathered knowledge among all EU MS

Focus on Youth, Football & Alcohol (FYFA)

- FYFA aims to **reduce underage drinking and heavy episodic drinking** among young people, as both strongly affect the health and welfare of Europe's population.
- FYFA will **review policies related to young people, sport, marketing and alcohol** with particular focus on football on international, national and local levels.
- Relevant stakeholders and decision makers will be interviewed at all levels. We will identify **one local youth football club in six Member States**, where young people, aged 13-15 participate in regular sporting activities and interview football club management to find out: attitudes, strategies to reduce drinking and harms for young people.
- Finally FYFA will organise an **international conference on Alcohol, Marketing, Sport and Youth** – launching the project findings and recommendations.

Purpose:

The EU dimension of alcohol related harm addressing the main challenges on alcohol related harm, lowering alcohol consumption and preventing alcohol abuse.

- To identify data gaps and further work on data and evidence and advice contributing to the reduction of alcohol related harm.

AWP 2018 - 4.1. Support to Member States in reducing alcohol related harm

Purpose:

- implementation of **best practices for early screening and brief interventions** as identified by the Joint Action on reducing alcohol-related harm and supported by evidence (e.g. from the OECD and WHO);
- implementation of **best practices for activities in schools** as identified by the Joint Action on reducing alcohol-related harm and supported by evidence;
- implementation of **best practices for public communication and awareness campaigns** as identified by the Joint Action on reducing alcohol-related harm;
- support to **capacity building**, sharing and implementing of best practices in the Member States, including via scientific networks, organising job shadowing, missions and knowledge transfer;
- organisation of **thematic meetings** focused on the above specific working areas and deliverables. The work would support and strengthen the work of Member States by facilitating a focus on the development of agreed deliverables and results.

AWP 2019 - 8.4. Support to Member States in reducing alcohol related harm

The proposed actions will

- -carry out a study on the **cross-border advertising and marketing in new media**, in order to have a better understanding of these practices and on the cross-border **implications and exposure of children and young people**. It would also be useful to map Member States' experiences with implementing and enforcing measures at the national level concerning marketing in new media.
- organise **workshops/capacity building activities in the areas of alcohol and workplace, production and consumption of illicit/unrecorded alcohol and application of eHealth tools** particularly in coordinated national campaigns to reduce alcohol related harm;

In addition, two studies should be carried out:

- - **A study mapping consumption patterns of low and zero alcohol beverages**, and analysing their impact on reduction of alcohol related harm (either positive or negative);
- - The study to **evaluate the impact of warning labels** which have existed already for some time (e.g. pregnancy, driving) on consumption patterns.

Research on alcohol related harm

- **Sixth framework programme (2002-06)**
Alcohol prevention, neurobiology, addiction, road safety (EUR 30 million)
- **Seventh framework programme (2007-13)**
Neurobiology, addiction behaviour, public health measures to reduce alcohol related harm
(EUR 59 Million)
- **H2020 (2014-20) challenge based approach**
Provides opportunity to address the effect of alcohol consumption; dementia, chronic disease, mental health, public health, health care



Examples of FP7 and H2020 projects

- **AAA-PREVENT (FP7)** - Alcohol use Among Adolescents in Europe, Environmental Research and Preventive Actions. Studied push and pull effects of a variety of risk and protective factors. Extensive comparison of the influence of the various domains and risk factors on youth substance use, between European regions and countries, taking into consideration the diversity of national alcohol policies and cultural and socioeconomic indicators.
- **ADDICTION (FP7)** Focus on interplay between genetic and environmental causes of individual variation in substance use and the risk for abuse. Twin studies demonstrated that both heritable and environmental factors play a role. Key objectives: 1) To unravel the complex contribution of genetic and environmental factors to substance use by using extended twin family designs; 2) To identify and confirm genes and gene networks involved in substance use
 - **ALICE-RAP (FP7)** better understand the determinants of addiction and dependence including a specific focus on youth. It studies the impacts of new technologies on use, the interrelations of culture and biology, and features that promote resilience and reduce problematic use.
 - **AMPHORA (FP7)** impact of public health measures and interventions, thereby providing better guidance for integrated policy-making aimed at reducing the harm done by alcohol.



H2020 projects ctd.

- **BEAMED (H2020)**

Drug and alcohol addiction cause a significant social and economic burden globally. Adequate diagnosis and treatment by general practitioners fails, in part due to a lack of knowledge and accredited training in addiction medicine. ... the goal of this project is to establish the feasibility and acceptability of training primary care practitioners in addiction medicine

- **GALAXY** Alcohol is the main cause of liver cirrhosis, which is considered irreversible but its precursor, liver fibrosis, is reversible when detected before disease progression. GALAXY proposes that crosstalk between the gut microbiome and the liver influences the development and progression of alcoholic liver fibrosis. Therefore, interventions aiming to restore a healthy gut microbiome will reduce disease development, to identify at-risk individuals in time and to develop personalised healthcare strategies for alcohol over-users (20% of the EU population >15 years old).

- **SYBIL-AA** Rational strategies for design and development of novel, evidence based therapies for alcohol addiction are still missing. Within this project, we will utilize a translational approach based on clinical studies and animal experiments to fill this gap. We will provide a novel discovery strategy based on systems biology concepts that uses mathematical and network theoretical models to identify brain sites and functional networks that can be targeted specifically by therapeutic interventions. unmet clinical needs, and thus help to address a serious and widespread health problem in our societies.



What is public procurement?

Public Procurement is the purchasing of works, supplies and services by public bodies.

The legal basis for the Commission and Chafea's procurement is laid down in the **Financial Regulation** and its **rules of application**.

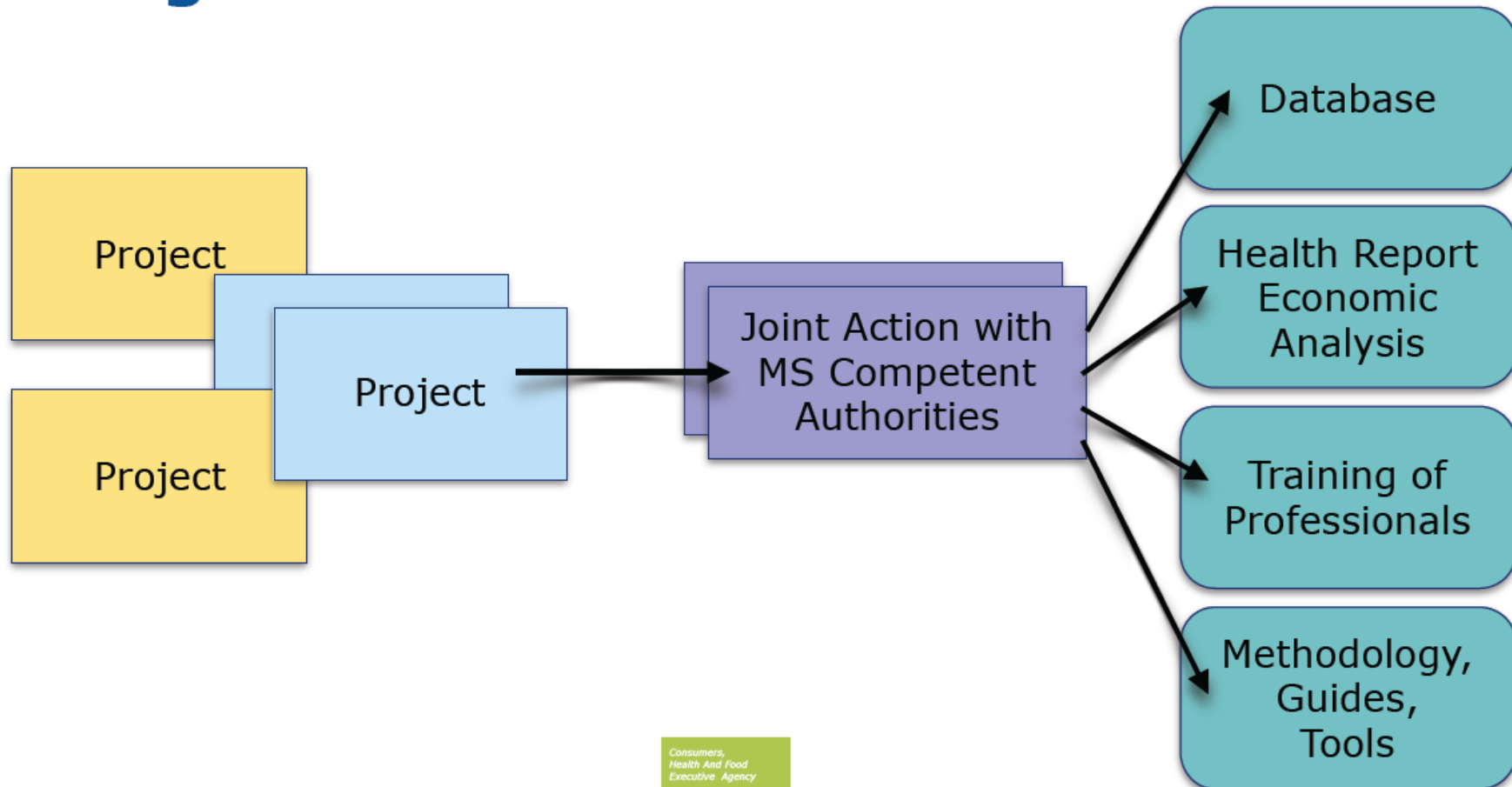

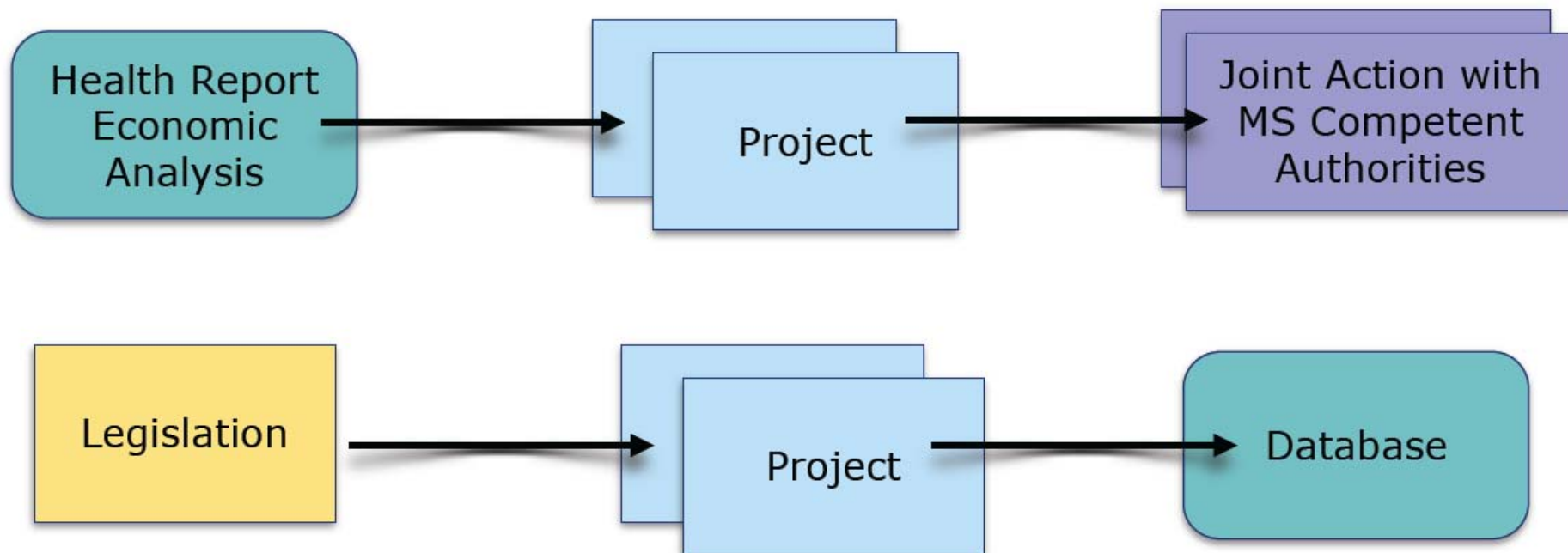
Service Contract (Procurement) vs. Project Grant

To acquire a product or a service.	Purpose	To encourage actions indicated in the Work Plan, which fall primarily within the scope of the beneficiary's activities
Call for tender	Procedure	Call for proposals
Service Contract	Legal outcome	Grant Agreement
The EU pays 100 % of the contract price	EU financial contribution	EU-contribution to the overall costs (Co-funding)
Since the service or product has been purchased and paid for by the EU, in general it belongs to the EU in its entirety	Ownership	The ownership as a rule is vested in the beneficiary of the grant.
The operator's remuneration should include an element of profit.	Profit	The grant must not have the purpose or the effect of producing a profit for the beneficiary.



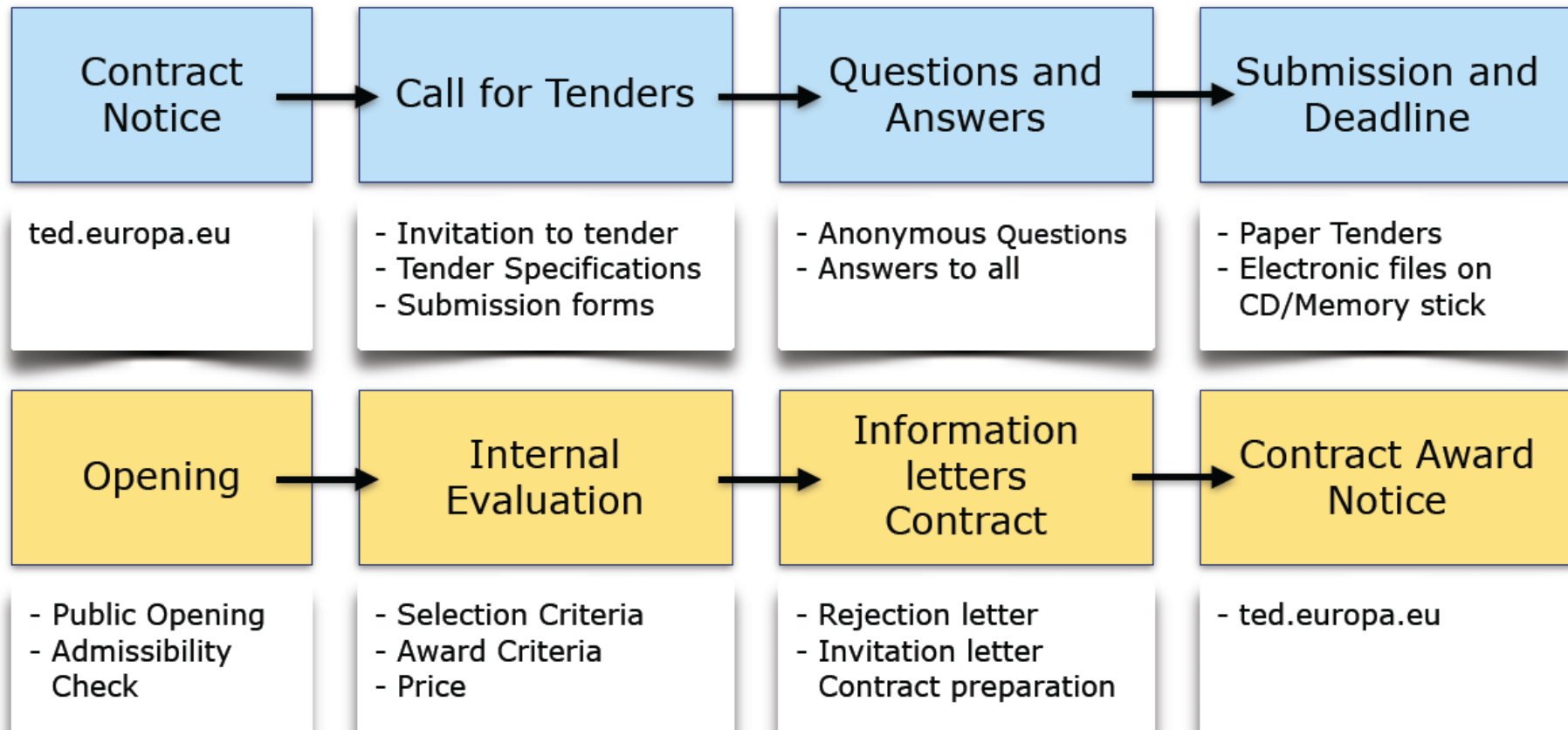

- Under the Stabilisation and Association Agreements (FYROM, Albania, Montenegro, Serbia, Bosnia and Herzegovina, Kosovo)
- European Economic Area (Norway, Iceland and Liechtenstein)
- GPA Parties (only in case of inter-institutional procurement)

- Single tenderer

Joint tenderers

The offer shall clearly specify the role and tasks of each member of the group:

- The **leader of the group**: with full authority to bind the consortium and each of its members
- Each partner shall fulfil the requirements and accept the terms and conditions set out in the TS, the contract as well as in all the relevant Annexes.

In case the tender is awarded the contract:

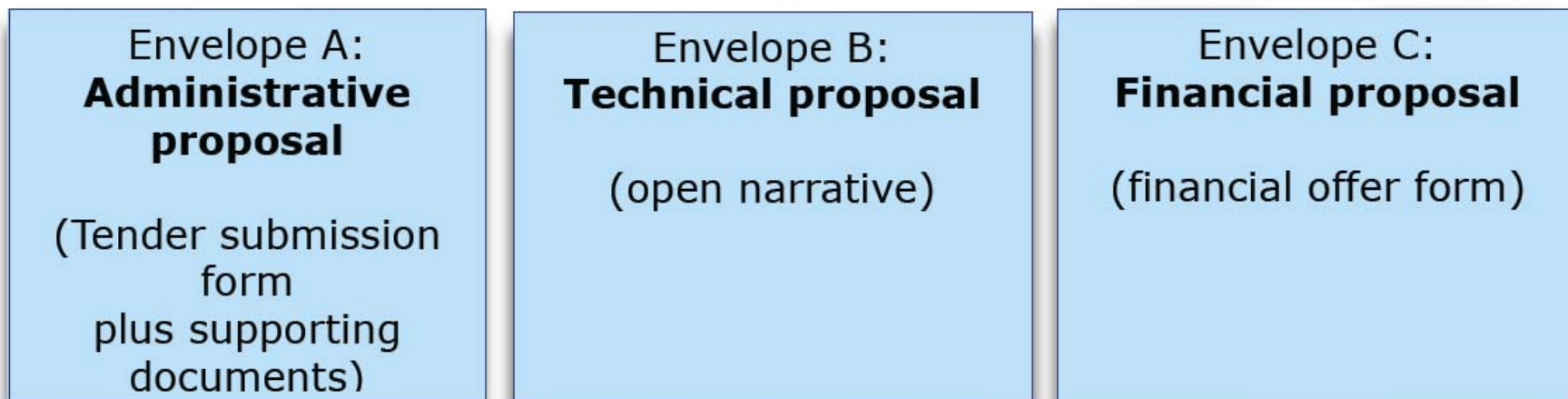
all members of the consortium will be jointly and severally liable towards the contracting authority for the performance of the contract.

Subcontracting

- Tenderers are required to identify subcontractors according to TS
- Identified subcontractors must submit letters of intent
- Change of subcontractor during implementation requires prior written approval by the contracting authority
- Rules on access to the market do not apply to subcontractors

Submission - 3 envelops

The Tender must include 3 envelopes:



The offer has to be sent to Chafea by registered mail or by courier post mail, in a sealed packet containing the 3 envelops, before the date of deadline.
