Health System in Ukraine

Baby-Friendly Hospital Initiative coordinated by The Coordinating Council of the Ministry of Health of Ukraine for the Further Implementation of the Expanded Baby-Friendly Hospital Initiative in Ukraine The health care reforms initiated in 2015 culminated in the Law on Financial Guarantees for Health Care Services Since 1996 Ukraine has implemented program to support breastfeeding

Primary health care in Ukraine is provided by public and private providers, including public communal providers, private institutions, or private practices.

Secondary care - city hospitals, maternity hospitals and children's city hospitals, region hospitals.

Tertiary hospital care - regional multiprofile hospitals, monoprofile specialized hospitals, regional children's hospitals, psychiatric hospitals, and tuberculosis and other monoprofile facilities. 1318 - total number of healthcare facilities that provide care for mothers and children 377 out of 1381 (28,6%) – number of health care facilities designated as baby-friendly 44 out of 725 (6,07%) - primary healthcare facilities designated as baby-friendly 333 our of 593 (56,1%) - Maternity hospitals, perinatal centers, adult and children's hospitals, pediatric hospitals, and pediatric polyclinics





The overall decrease in number of certified facilities from 41.5% in 2012 to 28.6% in 2023 is due to the establishment of new primary healthcare facilities - Primary Healthcare Centres and the merger of several facilities into one, occupation of territories due to full scale invasion of Russia

Since 1995 Ukraine has implemented program to support breastfeeding

According to Order No. 715 "On the Further Implementation of the Expanded Baby-Friendly Hospital Initiative in Ukraine," BFI covers all levels of health care facilities that provide health care for mothers and children (from perinatal centers to Primary Healthcare Centres

Apart from **Ten steps to successful breastfeeding**, International Code of Marketing of Breast-milk Substitutes and relevant World Health Assembly resolutions., implementation of advanced technologies and partner partner childbirth where also integrated (but need to be revised according to WHO 2018 recommendations)



The overall decrease in number of certified facilities from 41.5% in 2012 to 28.6% in 2023 is due to the establishment of new primary healthcare facilities - Primary Healthcare Centres and the merger of several facilities into one, occupation of territories due to full scale invasion of Russia

Barriers and facilitators for the implementation of the Baby-Friendly Standard in the community health services/ services after discharge from the maternity ward



Potential barriers

- Workload and work models of staff (family doctors, general practitioners)
- Low percentage of primary care doctors working with both adults and children
- Gaps in knowledge and skills of primary care staff; lack of training for primary care personnel
- Lack of continuity in breastfeeding support
- Regulatory documents are advisory, with no control mechanism for implementation
- Health care facilities do not perceive value in obtaining the relevant status
- Staff resistance due to lack of direct financial benefits
- High inertia among health care system
- Lack of funding
- Weak non-material governmental support and suboptimal capacity development
- Poor communication within clinical teams

Facilitators

- Availability of regulatory framework and a national breastfeeding support program
- Breastfeeding champions
- Advisory body providing training and methodological support to healthcare facilities and professionals
- Information campaigns to improve health literacy
- Multilevel intersectoral collaboration
- Political support at the national and regional levels
- Endorsement from both local administrators and government policymakers
- Effective leadership in the practice change process
- Training for healthcare workers and managers (including long-term perspectives)



Choice of the implementation site

Rationale for the implementation sites

For the pilot we chose 3 cities in different regions of Ukraine, which have certain cultural and regional differences and different degrees of implementation of child-friendly programmes.

Odesa region population 2100082

9.52% of health care facilitiesdesignated as BFH15166 were born in2023 66,03% of them in BFH

Volyn region population 874617 45% of health care facilities have the status of BFH 8121 children were

born, 62,79% of them in BFH







Choice of the implementation site



Kyiv population is **3453366** 19965 were born, 100,00% in BFH 88% of health care facilities are designated as BFH

The Coordinating Council of the Ministry of Health of Ukraine for the Further Implementation of the Expanded Baby-Friendly Hospital Initiative localized in Kyiv, which simplifies interaction and the possibility of involvement in the implementation of pilot activitiesis





Different settings of implementation

Critical risks and measures of mitigation



The main point is risks related to full scale invasion of Russia such as disruption of logistics, damage to facilities, threat to health and life will are difficult to managene but will involve agile strategy with identificaton and consideration of ongoing risks

Informing stakeholders about the project and initial discussion of goals and directions. 03


Holding a roundtable with stakeholders and discussing the degree of stakeholder involvement and their contribution to the project development.
