



















Participatory Approach & Needs Assessment in Community-Based Health Promotion

- Participatory Needs Assessment: actively involving stakeholders and community in identifying and analyzing needs to drive effective decision-making.
- Participatory Methods: e.g. Focus Groups & Workshops, Community Mapping, PhotoVoice
- → Considering Local Needs & Resources: Ensures feasible and effective solutions.
- **Community-Based & Context-Sensitive:** Development of health promotion measures tailored to the local context.
- Joint Action with Local Agents: Collaboration with stakeholders ensures relevance and sustainability.
- Engaging Key Stakeholders: Strengthens ownership and commitment.

- ✓ Anchoring health (promotion) in the Integrated Urban Development Plan (continuation of the Health Network)
- ✓ More physical activity in public spaces
- ✓ More children in sports clubs



Learnings - Community-based Health HEALTHAEUkids Vour Kidd Health, Our Priority

- 1. Acknowledge diverse health perspectives
- 2. Adopt a 'lifeworld' (Lebenswelt) approach
- emphasis on the additional benefits of health-promoting measures
- 4. Avoid (reinforcing) discrimination and guarantee low-threshold access
- 5. Address needs and interests of participants, residents, local institutions and decision-makers

- 6. Should be inter- and transdisciplinary
- 7. Ensure participatory process
- 8. Use theoretical and/or empirically impact model
- 9. Advocate for health equity, raise awareness of the consequences of social inequality
- 10. Needs political support to ensure reducing inequality through political and social strategies
